




El café Certificado Rainforest Alliance



BENCHMARK 4C CODE OF CONDUCT AND SAN STANDARDS

- Process carried out by Institute for Marketecology (IMO) in cooperation with International Social and Environmental Accreditation and Labeling Alliance (ISEAL)
- Standards benchmarked, which means that a producer who owns a farm that is Rainforest Alliance Certified may apply to receive the 4C License without the need for additional verification.
- This process, however, is <u>irreciprocal</u> due to the baseline character of the 4C Code, meaning that a verified 4C Unit is not automatically Rainforest Alliance Certified







ADVANTAGES OF BENCHMARKING

- A means to offer a wider market scope to coffee producers of the entire coffee chain.
- This one-way recognition gives Rainforest Alliance Certified farmers access to the cost-free 4C Support Services, in order to assist them in their continuous improvement towards sustainability.
- Moreover, it enables them to sell their surplus volume of Rainforest Alliance Certified coffee as 4C Compliant Coffee which is coffee produced and traded according to 4C Standards.
- Buyers within the market for coffee from 4C Verified Units reward the high quality of this coffee, which provides excellent trading conditions to farmers.

EL SALVADOR: COOPERATIVA CUIDAD BARRIOS

- 30 Farms involved in stepping-up
- Counts with the 4C verificacion (License Feb2010)
- Receiving technical assistance for the implementation of the SAN standards
- Cooperative will apply for RA certification at the end of 2010
- In total more than 900 MT of green coffee RAC & 4C verified will be available from this group

MAYOR ADDITIONAL CHANGES FROM 4C>>> RAC EN CIUDAD BARRIOS

- Development of a Management System at farm level
- Occupational health issues specially for workers and farmers that manage agrochemicals
- Protection of the water streams
- Warehouses for agrochemicals
- Housing for farmer and workers
- Equalize salary of women with that of men
- Soil erosion







COLOMBIA

Project area



- Project financed by USAID
- 901 producers participated
- Presence of illegal armed groups
- Displaced populations
- Lack of previous projects that provide technical assistance
- Extreme poverty, under the I USD per person level







FURTHER STEPPING-UP EXERCISES

- Tanzania: 2000 farmers, inclusion of a climate component
- Uganda: exchange with 4C Members started
- **Vietnam:** options currently being assessed Stepping-up did already take place in several 4C Units without accompanying
- Indonesia: concrete plans underway in context of a project with different partners (WWF) in South Sumatra







RAINFOREST ALLIANCE AND 4C JOIN NESTLÉ

- By 2015 180,000 MT of directly sourced coffee will be 4C Compliant, benefiting more than 170,000 farmers and their families
- By 2020 90,000 MT of Nescafé coffee will be sourced according to the Rainforest Alliance and Sustainable Agriculture Network standards, benefiting more than 75,000 farmers and their families
